# **Project Manager Position Available**

Valley Vision is seeking a highly motivated **Project Manager** to help us improve quality of life for all in the Greater Sacramento region. The desired candidate will have a passion for the greater Sacramento region and thrive in a fast-paced, collaborative environment. This position will work primarily on the California Jobs First (previously known as the Community Economic Resilience Fund ("CERF") program - a state-funded, highly collaborative program to develop and increase equitable access to high quality jobs in sustainable industries.

Typical duties the Project Manager would support include, but are not limited to:

- Providing technical assistance and support to community partners to foster their success.
- Coordinating the solicitation and work of sub-contractors and vendors to ensure effective and timely delivery of products and other outputs.

- Recruiting participation from community and institutional entities and fostering their ongoing engagement to ensure diverse voices are contributing to the identification of opportunities and needs, as well as direction and priorities
- Managing meetings and facilitating dialogue among diverse groups to reach consensus on priorities and decisions.
- Researching and analyzing information and making that information digestible for diverse audiences
- Monitoring and communicating program impact
- Preparing reports for community and funders to promote accountability

## Qualifications

The successful candidate will demonstrate prior experience in the above activities as well as possess the following characteristics and qualifications:

- Project management. The individual must have demonstrated prior experience in project management.
- Public contract management. The individual must have demonstrated prior experience in managing or compliance with federal, state, or other government grants.
- Interpersonal skills. The individual must be able to work with, communicate with, and build relationships with a variety of individuals and personality types.
- Inclusivity focused. The individual must be committed to expanding inclusivity and achieving equity in program outcomes.
- Flexibility. The individual must be nimble and able to respond to evolving conditions.
- Organized. The individual must be able to process multiple points of input and be able to prioritize and problem solve.
- Coalition management. The individual should have prior experience contributing to or managing coalitions or collaboratives.
- Regional awareness. The individual should have familiarity with the greater Sacramento region.
- Experience in economic and/or workforce development a plus.

The Project Manager is a full-time, exempt position. Typical hours are Monday through Friday from 8:30am to 5pm, however, may flex on occasion due to meeting or other work needs. Valley Vision currently operates in a hybrid work environment, with the ability to work from home or the office depending on project needs. In office presence may be required for specific one-time or recurring meetings. The project will also require some travel to locations within the greater Sacramento area (inclusive of Colusa, El Dorado, Nevada, Placer, Sacramento, Sutter, Yolo, and Yuba Counties).
