Overview: CERF Objectives

The Community Economic Resilience Fund is a \$600M state program by Go-Biz, OPR, LWDA, and EDD to:

- Support the development of meaningfully inclusive regional planning processes that produce regional roadmaps for economic development efforts that prioritize the creation of accessible, high-quality jobs in sustainable industries.
- Invest in projects proposed by regional planning tables that align with regional strategies and meet criteria for equity, job quality, and sustainability, among others.
- Align and leverage state investments (e.g., High Road Training Partnerships, community capacity building programs), federal investments (e.g., Infrastructure Investment and Jobs Act), and philanthropic and privatesector investments in regions to maximize economic development efforts.

Capital Region CERF: Program Timeline



PLANNING PHASE MARCH 2023 - JUNE 2024

- 13 regions, \$5M each
- Regional Collaboratives -Inclusive planning groups that include balanced representation from
- Regional Economic Plans

IMPLEMENTATION PHASE GUIDELINES WINTER 2024

- \$100M across the 13 regions
- 2-3 ready projects that align with the regional economic plan

CATALYST FUND PROGRAM 2024 - 2026

- \$26.5M for capacity building and project development
- Program details are still being considered



SHARED VISION: To develop an equity-based low-carbon economic plan through an inclusive, transparent, co-owned, and subregional datainformed planning process in the Capital region. The plan will produce strategies to generate high-quality jobs, clear pathways into new jobs for historically left out populations, and a sustainable and equitable economy in the eight-county region.

SHARED VALUES

OUR PROCESS IS INCLUSIVE WHEN we actively involve divergent voices and those often least engaged in the subregions of the Capital Region through accessible opportunities in the decision-making process with influence that valued, appreciated, and encouraged. Why Catalyst funds? Pre-development bridges the gap between planning and implementation Maximize funding streams Federal, state, and private funding available for ready-to-go


- - projects

 - More projects developed by and for disinvested communities















The Catalyst Program will allocate up to \$26.5 million per region to spur transformational investments.
